



2022 Progressive American Flat Track Contingency Award Program

The Progressive American Flat Track Contingency Award Program is designed to reward teams and riders based on results in events and the championship with cash awards from companies with approved products. Placement on the list does not automatically renew - partners must renew eligibility prior to each season. The first step in posting Contingency Awards for the 2021 season is completing the application, which is included in this document.

Award Types:

- **Per Race Awards** are posted for top position finishers in each race, for example: \$1,000 for a win, \$750 for second, etc. in each class. It is up to each company to determine the cash amount they want to pay out in Contingency Awards. In addition to a monetary award, the company may also award product to position finishers.
- **Championship Awards** are posted for specific finish positions in the year-end championship standings, i.e., \$5,000 for the champion, \$2,500 for runner-up, etc. for riders using an approved product. Championship Awards may be awarded to the top finishers in AFT SuperTwins, AFT Production Twins, AFT Singles or all three classes.

It is highly recommended that a company posts both per race and championship awards in all classes where their products may be used. Because only a portion of your total postings will be paid out, this allows you to advertise a much higher posting amount.

Contingency Award Requirements:

1. Awards may be cash or product awards.
2. Minimum Event Award posting is \$500 per event (per class) and the minimum posting for each finish position is \$25.
3. Minimum Year-End Award posting is \$1,000 per class and minimum posting for each year-end award position is \$50.
4. A posting and application must be for a single product. Additional awards must be posted for additional products. Example: If a company produces chains and sprockets, it must apply to post separate awards for each.
5. Partner is solely responsible for payment of awards, which shall be made within 14 days of notification from American Flat Track.

Sponsor Benefits: The Contingency Awards Program will provide exposure for your brand, logo and product(s) to riders in addition to a wide range of viewers watching in person, at events, and on FOX SPORTS.

Sponsor Decals: Contingency Sponsors are responsible for supplying Progressive American Flat Track with appropriately sized decals (**no larger than 4 square inches**) no later than 14 days prior to the first event of the series. Progressive AFT will make decals available to competitors at Technical Inspection. It is the rider/team's responsibility to display the decals on their motorcycle, which will be verified in Technical Inspection at each event in which a rider competes.

Official Results and Reports: Upon receipt of completed Contingency Award forms, Progressive American Flat Track will post your company's award information to the Progressive American Flat Track Contingency List so riders can decide which products they will use. When riders arrive at events, they will declare which products they are using at Technical Inspection, and Progressive AFT staff will verify that required decals/patches are in place for each product they are using. Following each event, a report will be compiled listing the results for each race based on the products used and will be sent to each company indicating which rider(s) earned awards for product usage, amount of award they are owed and contact information. Once the official report is received, partner is responsible for awarding prize(s) within 14 days.
